There will be 2,000 plus International Delegates, Industry Experts and they shall deliberate on the burning issues relating to Road Sector such as, Roads and their users, Role of Roads in Trade & Life, Roads and their impact on Society etc.

Coinciding with Meeting, an area for having Country Pavilions is also scheduled to be held, where in, the Exhibitors of International repute would participate and showcase their innovative products and technologies, taking place world over. The occasion would provide platform and opportunity to meet Industry experts, network and exchange ideas and discover innovative technologies, apart from making an International Business connection.

- (vi) Consultants and Contractors could showcase their capabilities.
- (vii) Holding Business meetings and clinching possible Joint Ventures, etc.

The event is a rare opportunity. Indian Road Sector players are welcome and invited to Participate at India Pavilion in Lisbon. The dates 25th to 28th May 2010 be marked in their diary.

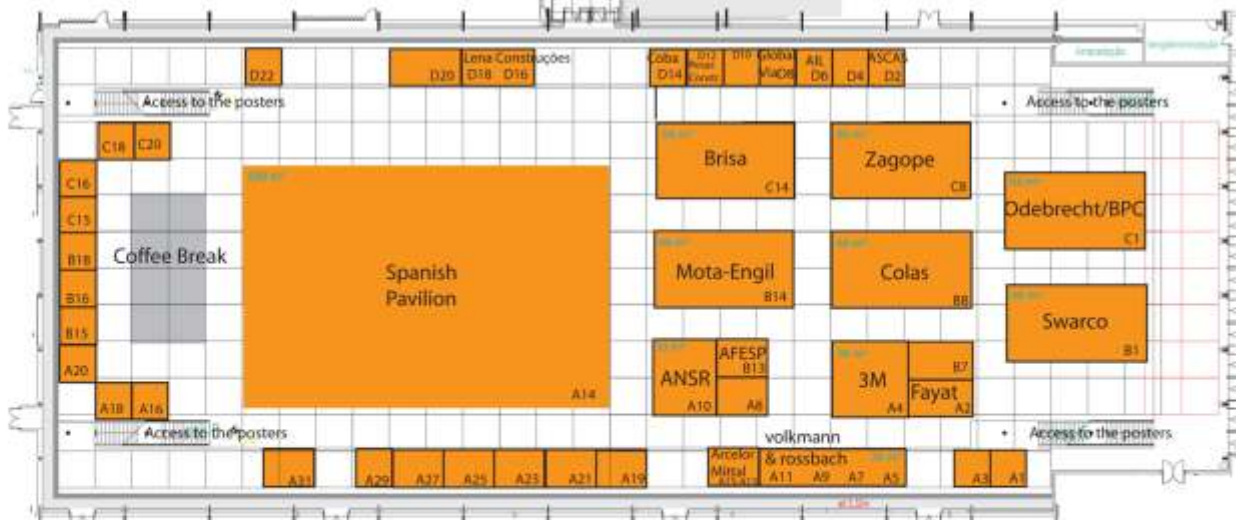


EXHIBITION FLOOR PLAN

The history of Beato Monastery dates back to the 15th century, when Queen Isabel, wife of King Afonso V, was given authorisation to build a hospice in the chapel of S. Bento for the congregation of “frades azuis” – the blue monks. Before she was able to fulfill her wish, the Queen died, leaving 8,000 gold coins in her will for the hospice construction.

In 1984, the Beato Monastery was classified as a Heritage Site of Public Interest.
