First Responder Enhanced First Aid (eFD) Training on NH-24 Delhi-Meerut Stretch

Executive Brief

- I. During the Road Safety Week 2019, the Ministry of Road Transport & Highways (MoRT&H), vide their Letter No. RT-25035/04/2019-RS dated 07.02.2019, sanctioned to International Road Federation India Chapter (IRF IC), the following projects with total financial sanction of Rs. 9,94,550/=:-
 - (a) Organising Workshop on Emergency Care (Protection of Good Samaritan & First Responder Training) With financial grant of Rs. 3,21,550/=.
 - (b) First Responder eFD Training on NH-24 Delhi-Meerut Stretch With financial grant of Rs.6,73,000/=.

This Report relates to carrying out *First Responder Enhanced First Aid (eFD) Training* on NH-24 Delhi-Meerut Stretch.

- II. The project as conceived by IRF IC was to be carried out in two stages: (a) Pre-survey for meeting with District officials and Heads of Institutions, identifying training locations and enrolling participants and (b) Training of the identified participants.
- III. The project was initiated and the Pre-survey was carried out between 13th to 15th February 2019. However, due to various unavoidable circumstances, such as the Code of Conduct coming into force on account of the General Elections announcement, inclement monsoon weather, pollution related breaks and law and order issues, the project could only be finally taken up in December 2019. The pre-survey, including meetings with District Magistrates of Ghaziabad and Meerut and Police officials had to be repeated due to changes of concerned district officials and was undertaken between 26th November 2019 to 21st January 2020.

- IV. The training was conducted from 22nd January 2020 to 13th February 2020 at 7 locations; Duhai, Rajnagar Extn., Morta, Muradnagar, Mohiuddinpur, Bhadbhuaral, Subharti College, Bypass Road Meerut and Surajmal College, Sakhoti Tiraha Bypass. The resulting training of 330 trainees as against the targeted 245 trainees under the project has resulted in incremental safety on the National Highway 24 Delhi-Meerut Highway stretch through creating a pool of 330 trained First Responders.
- V. Feedback of 90% of the trainees was that the training was good and useful in all respects.



First Responder Enhanced First Aid (eFD) Training on NH-24 Delhi-Meerut Stretch

1. INTRODUCTION

- 1.1 During the 30th National Road Safety Week 2019, the Ministry of Road Transport & Highways (MoRT&H), vide their letter No. RT-25035/04/2019-RS dated 07.02.2019 (*Annex. 1*), sanctioned to International Road Federation India Chapter (IRF IC), the following projects with total financial sanction of Rs. 9,94,550/=;
 - (a) Organising Workshop on Emergency Care (Protection of Good Samaritan &

First Responder Training) – With financial grant of Rs. 3,21,550/=.

(b) First Responder eFD Training on NH-24 Delhi-Meerut Stretch – With financial grant of Rs. 6,73,000/=.

The Report relates to carrying out *First Responder Enhanced First Aid (eFD) Training on NH-24 Delhi-Meerut Stretch*.

2. PROJECT RATIONALE

2.1 Emergency care is one of the major E of the 4 Es of Road Safety and the only E that comes into play, post an accident. The importance of the Golden Hour in saving valuable lives on roads is a well recognised concept of emergency care.

2.2 The rationale for the Project, aimed at providing training to First Responder Bystanders on Delhi-Meerut stretch of Highway 24/58, is that in case of a traffic accident, other road users, citizens located close to accident sites, the drivers and occupants of passing vehicles, as well as members of road side facilities are likely to reach the victim before any formal qualified rescue service. Competence, capacity and confidence developed in the local community, road stakeholders and road users through eFD training to be first responders for traffic injuries can have a major impact on reduction of mortality and morbidity on the roads.

3. PROJECT IMPLEMENTING AGENCY

- 3.1 Backed by the formidable body of technical expertise of its members, the nonprofit India Chapter of the Geneva based International Road Federation (IRF IC), focuses on activities for safer, smarter, greener roads and smart mobility.
- 3.2 A pioneer in Road Safety activities in the country, IRF IC has been aggressively pursuing awareness generation activities, improvements in legal environment and enforcement, had signed a Statement of Intent with NITI Aayog, India's premier policy making agency and, engineered the Delhi Declaration 2017, signed by Global Transport Ministers in the wings of IRF World Road Meeting hosted by IRF IC in 2017. IRF IC is also represented on the Central Motor Vehicle Rules Technical Standards Committee. Multi-level awareness building activities include 9 internationally lauded Regional Conferences on various aspects of Road Safety; 4 International Roundtables on ITS; select recommendations of which have translated into policies including Income Tax Exemption for road safety initiatives; School education programmes including designing an integrated school curriculum to "catch them young"; road shows and promos in visual media; screening short films in regional languages on Drunken Driving, Good Samaritan Law, Helmet Use, Speeding and Jingoism, radio series "Roads have Stories", etc.

- 3.3 Awarded for its research and setting standards for use of reflective tapes on bicycles, with the Maruti Suzuki TimesNow Road Safety Award, IRF IC has affixed luminous conspicuity tapes on around 200,000 bicycles for ensuring safety in dark hours; Investigated and developed rectification measures for Blackspots in Delhi and Nagpur; designed and launched Government Certified Courses on Road Safety Audit at IAHE, in association with Australian Road Research Board (ARRB). The Road Accident Data Recorder (RADaR), a first of its kind on-site crash data collection system in India was developed using a handheld tablet with cloud/server connectivity. It has also developed Changer, a Greenhouse Gas Calculator for harmonized assessment and normalization of Greenhouse Gas Emission for Roads.
- 3.4 Most importantly, and of relevance to the current Project, IRF IC had pioneered eFD Training of commercial Drivers and Bystanders, and garnered considerable experience in delivering First Responder Bystander Training, having trained around 20,000 commercial drivers and bystanders all over the country since 2015. The first such pilot project was executed with the support of **MoRT&H** in 2015.
- 3.5 For its work on Enhanced First Aid training for First Responders, involving development of training manuals (in collaboration with MoH&FW, WHO and AIIMS) and training around 20,000 commercial drivers and bystanders, IRF IC was awarded the coveted International Prince Michael Road Safety Award.
- 3.6 It was in recognition of this expertise that the MoRT&H in a preliminary Meeting to design the activities for the 30th Road Safety Week, assigned to IRF IC the primary responsibility of undertaking activities related to Emergency Care.

4. **PROJECT COMPONENTS**

- 4.1 The Project aimed at providing Training to bystanders, on the selected highway stretch of around 90 kms., in Basic First Aid, Initial Assessment & Management of Trauma Victims, Cardiac Pulmonary Resuscitation (CPR) and delivery of practical hands-on skills to improve survival opportunities of road crash victims.
- 4.2 The Training was to be customised in particular to handle trauma and injuries and to meet the minimum medical and resuscitation attention required for safe transportation of the patient to a medical care facility.
- 4.3 A total number of 245 bystanders were targeted to be trained under the Project at7 locations with a batch size of around 35 persons, along the selected Delhi-Meerut Highway stretch.

5. PROJECT METHODOLOGY

- 5.1 The Project was envisaged to be carried out in 2 stages:
- A. Pre-survey
 - A Pre-survey was to be carried out of the road stretch, for identification of local establishments, training locale and enrolment of participants.
 - Identification was proposed to be done for both sides of the Highway through personal contact, house to house visits, organisation contact, meeting officers of Government & Institutions, and seeking support from local administration, etc. All relevant details were to be collected at the Survey stage, subject to availability.
 - Trainee selection was to adhere to a minimum qualification of 10th grade, with age of trainee being restricted between 18 to 50 yrs.
 - 7 locations were to be identified, along with adequate training facilities at each location and confirmation of approvals for organizing the training at the premises to be obtained – Preference was to be given to Government or Public Places.

- Boarding / lodging at location site was also to be identified nearest to the location, to save on travel time and cost.
- B. Training
 - The Training syllabus was to be designed to cover essential skills. At the end of the Training, a formal assessment was to be conducted and participants to be evaluated and given certificates of participation.
 - The duration of training of the batches at individual locations was to be 1 day each, from 9:30 AM to 5:30 PM.

6. PROJECT EXECUTION

(a) Pre-Survey: IRF IC carried out the initial Pre-survey between 13th to 15th February 2019, with a 3 member Team comprised of Program Coordinator (1) and Trainers (2). Since, the Delhi-Meerut stretch is a short stretch; it was decided to make trips to the different select locations with Delhi as the base, instead of camping close to the site as originally envisaged.

At the outset, the Team held meetings with the District Magistrates of Meerut and Ghaziabad Divisions, which are the administrative Divisions within which the stretch targeted to be covered lay, to seek their support in various matters. Their direction to various local establishments and institutions to enroll their participation and provide training facilities was foreseen to be invaluable.

A couple of meetings and visits down the line, dates for the training were under finalisation, when the project had to be unavoidably postponed due to the announcement of General Elections in the country and subsequent applicability of the Code of Conduct. The Director, MoRT&H was duly informed of this postponement vide IRF-IC letter dated 27th March 2019 (*Annex. 2*).

Although, several attempts were made to restart the project subsequent to the elections, due to various reasons such as transfer of district officials with whom contact had been established and new persons not yet in position, inclement monsoon weather conditions, law and order problems in the targeted areas, pollution related breaks in institutions, the Project could not be re-started.

The Project could be again re-initiated only in December 2019. A letter addressed to various Institutions and officials of District Meerut in this regard is at *(Annex. 3)*.

MoRT&H was again duly informed regarding the same vide IRF-IC letter dated 25th November 2019 (*Annex. 4*).

(b) Training Period: As a result of the many changes in officials in various Institutions and Departments, the initial Pre-Survey had to be repeated, and fresh meetings with the new District officials held, to renegotiate the training related decisions. The Pre-survey including meetings and contacts with District Magistrates of Ghaziabad and Meerut and other officials of the respective districts was conducted from 26th November 2019 to 21st January 2020.

With the inputs and support of the DCPs, Meerut and Ghaziabad, the Project was successfully reignited in December 2019 and was completed on 13th February 2020.

(c) Location wise Details of Training: The 7 locations chosen for the training sessions in the two districts of Ghaziabad and Meerut along with the dates and number of trainees who underwent the Training are chronologically listed below.

(d) Number of Trainees: As against 245 trainees targeted under the project, a total number of 330 participants were trained in eFD under the Project. The attendance sheets are at Annex. 5.

The number of attendees, taking into account staff members of institutions who were also present during the training sessions, was 330.

These included personnel of various roadside amenities including residents, attendants of petrol pumps, personnel of local shops and dhabas, automobile shops, medical shops, hospitals, transporters, farmers, traffic police, Taxi Drivers from taxi stands located along the highway stretches, university students and teachers, etc.

(e) Training: The Training Team consisted of CEO & Director, IRF IC, Project Coordinator and 2 Supervisors.

The Training covered the Curriculum listed at Annex. 6.

After an initial hour of lectures on theory, which included orientation on the Good Samaritan Law, the concept of Golden Hour and the importance of the administration of aid to the road accident victims within the Golden Hour, the Trainers proceeded to conduct live demonstrations on volunteers from the audience.

A copy of the Good Samaritan Guidelines was circulated to the trainees along with other Training Material.

Batches of the Trainees were given hands-on training until they expressed satisfaction of having understood the techniques and confidence in their ability to practice them in case of emergent situations. Rotational technique was adopted for this purpose until all trainees were covered.

- *(f)* **Assessment:** At the end of the Training session, the trainees were assessed for their understanding and ability to perform in live situations.
- (g) Feedback: Feedback forms were circulated to all the participants. A sample copy of the Feedback Form is at Annex. 8.

Feedback forms were collected, analysed and the result of the analysis is at *Annex. 9.* Although there were 330 trainers, only 141 trainees gave feedback in the questionnaire canvassed.

The general feedback (90%) was that the training was good and useful in all respects. 91% of the answers to whether the training fulfilled the learning objectives of the trainees, ranked the course highly in this regard. The topics covered were found highly relevant and easy to understand by 89%. 88% were confident of their ability to perform after the training. However, only 83% expressed intentions of putting their learning into practice. The course design, practice and methods applied was found satisfactory by 90% of trainees and appreciated by 92%. The trainer's knowledge and ability to deliver was appreciated by 95% of trainees.

- (h) Certification: Certificates of Participation were issued to the participants.A sample copy of the Certificate is at Annex. 10.
- (i) Project Impact: The Project has resulted in skilling 330 First Responders in the eFD portfolio of Basic Life Support Techniques. Although a drop in the vast sea of potential, this is a good beginning in the direction of saving valuable lives on roads.

7. PROJECT COMPLETION REPORT AND FINANCIAL CLAIMS

7.1 The Project Report was consolidated and was to have been submitted along with the Financials of the Project duly audited and certified by a Chartered Accountant. The Ministry was informed of this vide our email dated 20th March 2020 (Annex. 11). However, the National Lockdown due to the Covid 19 crisis intervened and the accounts and audit were correspondingly delayed. The MoRT&H was addressed regarding this problem vide IRF IC email dated 23rd March 2020 (Annex. 12).

Dear Mr. Choudhary,

This is with reference to Letter No. RT-25035/04/2019-RS dated 07.02.2019 regarding "Grant of Financial Support to IRF IC towards organizing Workshop on Emergency care (Protection of Good Samaritan & First Responder Training)" and our subsequent letter dated 12th February 2019 on the subject (copy attached).

In this connection, I am to inform you that IRF IC team, comprising of 1 Project Coordinator and 2 Trainers, visited the site between 13th to 18th February 2019 for conducting the Pre-survey. They had discussions with District Magistrates of Ghaziabad and Meerut, the District Commissioners of Police, Institutional heads and also identified Bystanders to be trained and locations for conducting the training. Tentatively the locations identified are (i) Vaishali/Vasundhara – ITS College, Mohan Nagar, (ii) Meerut-Tiraya/Raj Nagar Extn./Morta – Raj Kumar Goel Institute of Technology, Raj Nagar Extn. (iii) Duhai – HLM Group of Institute, Duhai (iv) Muradnagar – KIET Group of Institutions, Muradnagar (v) Moti Nagar – SRM Institute, Moti Nagar (vi) K N Modi/CMD Group of Institutions (vii) Mohinuddinpur (Meerut).

Unfortunately, due to the announcement of General Elections in the country since and consequent applicability of the Code of Conduct, the Training component of the Project had to be essentially postponed.

Accordingly, we would now endeavor to take up the training at selected locations at the earliest, preferably by third week of April if we are permitted to do so, since Elections in this belt is due to be held on 11th April. If for any reasons the authorities do not agree to hold these trainings in the third or fourth week of April, we will have to essentially do it after the elections are over.

We request you to kindly take note of this development and the period of sanction of the financial support for the component of First Responder Training may be adjusted accordingly.

We look forward to your kind affirmative response.

This is with reference to the sub-component of *First Responder eFD training on NH-24 Delhi-Meerut* stretch vide Grant Letter No. RT-25035/04/2019-RS dated 07.02.2019 from the Under Secretary, MoRT&H, regarding Grant of Financial support to IRF IC towards organizing Workshop on Emergency Care (Protection of Good Samaritan & First Responder Training) during Road Safety Week 2019.

It would not be out of place here to mention that we have had a very enthusiastic response to the training and the feedback has been good with very positive views expressed regarding the usefulness of the training and the need for this to repeated.
